Call to Order:

Meeting: Call to Order – Call to order made by Commissioner Rogalski at 6:30 p.m.

Introductions:

Commissioners: Floyd Rogalski, Carrie Youngblood, Ingrid Vimont, Hartwig Vatheuer and Fred Benjamin. Superintendent: Julie Petersen; Treasurer: Scott Olander; Ancillary Operations: Rhonda Holden and EMS Manager: Geoff Scherer.

Approval of Agenda:

Action: A motion to approve the agenda was made by Commissioner Vatheuer and seconded by Commissioner Youngblood. Motion carried.

Approval of Minutes:

Action: A motion to approve the minutes of September 19, 2022 was made by Commissioner Benjamin and seconded by Commissioner Vatheuer. Motion Carried.

Action: A motion to approve the minutes of September 28, 2022 as amended was made by Commissioner Benjamin and seconded by Commissioner Youngblood. Motion Carried.

Operations Report:

The Commissioners reviewed the written operations report and operating statistics prepared by Geoff for September 2022. September transports were below budget by 4 transports. 2022 transports through September are at about the same level of 2021 transports though September. Geoff needs to purchase a power cot for the new Ford ambulance. The cot from the old ambulances cannot be modified to work in the new Ford ambulance. Price quote for the new power cot is \$36,132.43. There is some additional equipment that will be needed for the power cot.

Action: Commissioner Benjamin moved to authorize Geoff to purchase a new power cot and additional equipment for \$43,000. Commissioner Youngblood seconded the motion. Motion carried.

Geoff discussed the need for new cardiac monitors. Medic One currently has three cardiac monitors. The oldest monitor is 12 years old and the newest is 8 years old. Geoff will continue to investigate other options to upgrade the cardiac monitors.

Superintendent's Report:

The Commissioners reviewed and discussed Julie's written report. Julie discussed the initial meeting with IAFF 4880 to negotiate a new labor agreement. The District and IAFF believe that the existing agreement is fundamentally fair and clear and is a good starting point for contract negotiations. Julie would like to do a wage only reopener. The labor union needs to conduct a vote of their members to authorize a wages only reopener. Julie also discussed the open carry legislation that will impact the District.

There was follow-up discussion regarding the Joint District 2 and District 1 Board of Commissioners meeting on September 28, 2022.

Action: A motion was made to authorize administration to collaborate with Hospital District 1 to identify services and property to serve the strategic plans of Hospital Districts 1 and 2 was made by Commissioner Vatheuer and seconded by Commissioner Youngblood. Motion carried.

Ancillary Report:

The commissioners reviewed and discussed the written ancillary report. Rhonda also provided a letter dated October 10, 2022 sent to Jeff Ding, a Planner with EA Engineering, in response to his request for updated information about Kittitas County Public Hospital District 1 and District 2. The letter discussed the impact of the 47 Degrees North Project on District 1 and District 2 operations. Rhonda asked if the District wanted to support a flu vaccination clinic as has been done in previous years.

Action: Commissioner Benjamin moved that the District spend \$2,000 for an upper Kittitas County flu vaccine clinic. Commissioner Vimont second the motion. Motion carried.

Finance Report:

The financial statements for September 2022 were reviewed and discussed by the Commissioners. The review included a review of actual versus budgeted revenue and expense variances. Medic One did 66 transports in September, 4 transports below the September budget. September transport revenue exceeded budget by \$1,146 because the average charge per transport exceeded budget by \$152 per transport. YTD transport revenue exceeds budget by \$65,758. September contractual adjustments were below budget by \$4,952. September expenses were below budget by \$13,794. Benefit expenses were below budget by \$20,897 because an extra benefit payment related to September was posted in August. YTD benefits are correct. YTD expenses are \$25,483 below budget. Medic One recorded Net Income of \$10,182 for the month of September. YTD the District has a positive Net Income of \$92,480; and a positive budget variance of \$104,981.

Page 3

Geoff and Scott discussed a water leak in the pipe that provides water to the old ambulance station. The District's water usage is estimate to be \$200 per month greater than it should be due to the leaking water pipe. Geoff has a quote from Belsaas & Smith for \$34,790 excluding sales tax to complete the repair. Belsaas & Smith is on the District's small works roster.

Action: A motion to authorize Geoff to contract with Belsaas & Smith to repair the leaking water pipe was made by Commissioner Rogalski and seconded by Commissioner Benjamin. Motion carried.

Action: A motion to approve the warrants for September was made by Commissioner Youngblood and seconded by Commissioner Vatheuer. Motion Carried.

Levy Update:

Commissioner Rogalski provided an update of the levy committee activities. Signs supporting the levy are up, mailers supporting the levy have been sent, Commissioner Rogalski and levy committee member Louie Osmonovich met with a reporter from the Northern Kittitas County Tribune to educate the reporter about the need for the levy increase. Other members of the levy committee have meetings scheduled with community service organizations to educate about the levy. Feedback from the community about the levy has been positive.

Executive Session:

There was no executive session.

Announcements:

The next regular meeting date: November 21, 2022 at 6:30 pm in the UKC Medic One Ambulance Station located at 111 Pine Street, Cle Elum, WA.

47 Degrees North

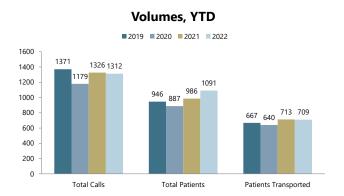

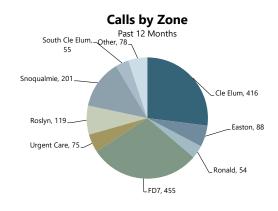
Rehab Services

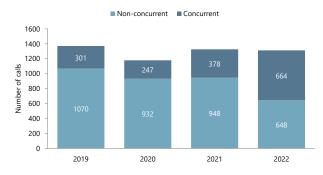

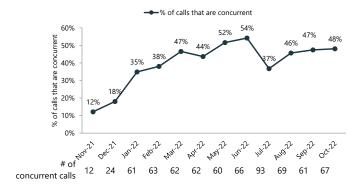




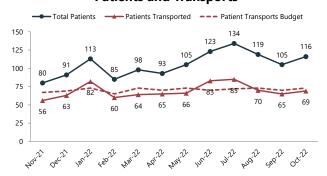
Concurrent Calls, YTD

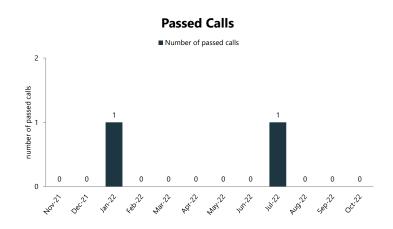

Turnout Time - Dispatch to Enroute

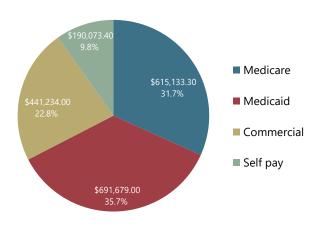

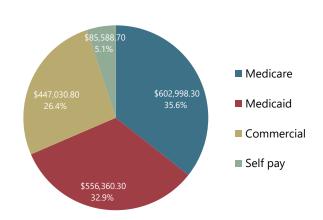
Payor Mix by Charges

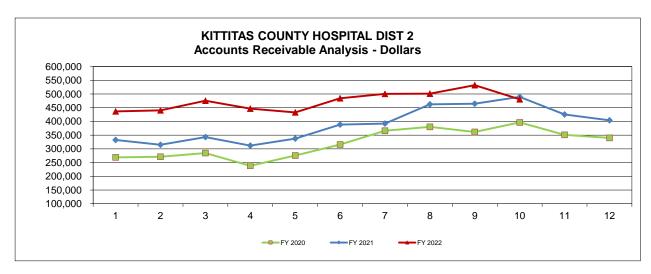

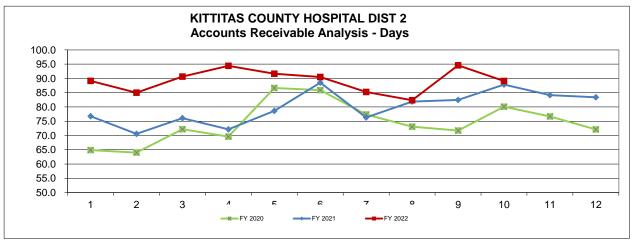
